Dear Roger:

At a recent meeting with the NAC Large Events Committee, I committed to seek the backing of the Board of Trustees to memorialize the agreements we reached together. I am happy to report that at the Trustees meeting, held July 22, 2008, I was given unanimous approval to commit to the following:

1. Denver Botanic Gardens will limit the number of major events, held in the evening and including outdoor amplified music, to no more than 17 per calendar year.
2. No more than 14 of such events will be concerts.
3. Events held during the evening means those that take place in whole or in part after 5:00 pm.
4. This commitment will ensue January 1, 2009 and will last five years.
5. If an occasion arises that extends beyond this commitment (for example, a mayoral inaugural party), Denver Botanic Gardens will require the approval of the NAC Board prior to allowing such an additional event to occur.

Thank you for continuing to build a healthy and productive relationship between the Gardens and our neighbors.
